BOARD ORDER

The President called said Complaint for hearing, the State announced ready and the RESPONDENT, ROBERT BAXENDALE, D.P.M., announced ready and was represented by Counsel. The Board proceeded to hear and receive evidence and testimony and after hearing and receiving all of same and after questioning the witnesses, the Board makes the following FINDINGS OF FACT and CONCLUSION OF LAW.

FINDINGS OF FACT

1. All jurisdictional requirements have been met.
2. On or about July 18th, 1985, Dr. Robert Baxendale, holder of License Number 796, did perform an operation on [REDACTED], under unsterile conditions at his office.
3. Operating on a patient under unsterile conditions constitutes a failure to practice podiatry in a manner consistent with public health and welfare.

CONCLUSION OF LAW

Dr. Baxendale is guilty of violating Article 4567(c) and Article 4570(d) (16) in that he performed an operation under unsterile conditions which constitutes a failure to practice podiatry in a manner consistent with public health and safety.

O R D E R

BE IT KNOWN that on the 16th day of August, 1986, a quorum of the TEXAS STATE BOARD OF PODIATRY EXAMINERS have voted, by majority vote, to REVOKE License Number 796, heretofore issued to Robert A. Baxendale, D.P.M., of Grapevine, Texas.

IT IS ACCORDINGLY ORDERED that License Number 796, heretofore issued to Robert A. Baxendale, D.P.M., is hereby REVOKED.






